



Conditions

These Terms & Conditions (“Terms”) govern all Corporate Memberships offered by **Fereneze Golf Club** (“the Club”). By purchasing or using a Corporate Membership, the purchasing organisation (“the Corporate Member”) agrees to abide by these Terms.

1. Membership Overview

1.1. Corporate Membership provides organisations with access to golf, guest rounds, hospitality benefits, and promotional opportunities as outlined in the selected membership tier.

1.2. The Club reserves the right to update package inclusions, pricing, and policies annually.

2. Membership Tiers

Corporate Membership is available in four tiers:

- **Bronze Membership**
- **Silver Membership**
- **Gold Membership**
- **Platinum Membership**

Each tier includes features and entitlements as published by the Club and supplied in the Corporate Membership Package.

3. Named Corporate Members

3.1. Each Membership tier includes a specified number of Named Full Members (“Named Members”).

3.2. Named Members must be nominated by the Corporate Member during registration.

3.3. Changes to Named Members may be requested once per membership year, subject to administrative approval.

4. Tee Time Access

4.1. Tee times for all tiers are subject to Club restrictions and availability.

4.2. Corporate Member play is permitted:

- Saturdays after **2:00 PM**
- Tuesdays (Medal Days) after **3:00 PM**

4.3. Additional Sunday restrictions may apply during competitions.

4.4. All tee bookings must comply with Club booking procedures.

5. Guest Rounds

5.1. A “Guest Round” is a round of golf allocated to the Corporate Membership for use by staff, clients, or invited visitors.

5.2. Guest Rounds may be used with or without the presence of a Named Member.

5.3. A fourball booking uses **four (4)** Guest Rounds.

5.4. All guests must sign in on arrival at the Pro Shop or designated location.

5.5. Guest Rounds must be played within the stated tee time restrictions.

5.6. Unused Guest Rounds do **not** carry forward to future membership years unless otherwise agreed in writing.

5.7. **Gold Membership** includes Guest Rounds under a “fair use” policy as defined by the Club.

5.8. **Platinum Membership** includes unlimited Guest Rounds, subject to fair usage rules and availability.

6. Corporate Golf Days (Platinum Tier Only)

6.1. Platinum Members are entitled to **two (2)** corporate golf days per membership year.

6.2. Each event may include up to **24 players**.

6.3. Dates and times must be booked in advance and are subject to course availability.

6.4. Catering and additional services may be arranged at the Corporate Member’s expense unless otherwise covered by the catering credit.

7. Catering Credits & Bar/Catering Discounts

- 7.1. Catering credits (where included) may be used toward food and beverage purchases within the Club.
- 7.2. Discounts for bar and catering purchases (10%, 15%, or 20% depending on tier) apply only to purchases made by Named Members or approved representatives.
- 7.3. Credits are non-transferable and must be used within the membership year. No cash equivalent is provided.

8. Hospitality & Lounge Hire

- 8.1. Complimentary lounge hires are included in all tiers, with the quantity determined by membership level.
- 8.2. Additional lounge hires may be booked at standard rate.
- 8.3. All hospitality bookings are subject to availability and Club event policies.

9. Sponsorship Items

- 9.1. Some tiers include sponsorship benefits such as tee boards, practice area signage, or competition sponsorship.
- 9.2. Sponsorship items will be allocated on a first-come, first-served basis.
- 9.3. Artwork and branding must comply with Club standards and may require approval before installation.

10. Fereneze Sponsors Day

- 10.1. Eligible membership tiers include team entries to the Fereneze Sponsors Day.
- 10.2. The Club reserves the right to modify event format, number of teams, or date.

11. Membership Fees & Payment

- 11.1. Membership fees are payable annually in full unless otherwise agreed in writing.
- 11.2. Membership is non-refundable except where required by law or at the Club's discretion.
- 11.3. Failure to pay fees by the due date may result in suspension or cancellation of membership.

12. Conduct & Compliance

12.1. All Corporate Members, Named Members, and guests must comply with:

- Club rules
- Course etiquette
- Dress code
- Health and safety policies

12.2. The Club reserves the right to remove access to facilities for behaviour deemed unsafe, inappropriate, or contrary to Club standards.

13. Liability

13.1. The Club is not liable for personal injury, property loss, or damage unless caused by the Club's negligence.

13.2. The Corporate Member is responsible for the behaviour and compliance of all guests and representatives.

14. Termination

14.1. The Club reserves the right to terminate a Corporate Membership for serious or repeated breaches of these Terms.

14.2. No refund will be issued in cases of termination due to misconduct.

15. General

15.1. These Terms may be updated periodically; the Club will notify Corporate Members of any significant changes.

15.2. By renewing membership, the Corporate Member accepts any updated Terms in full.
